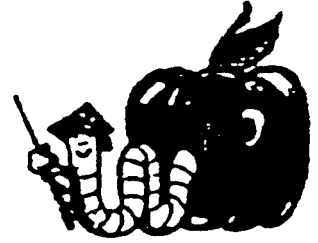

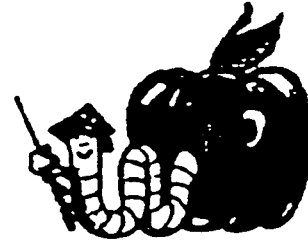

- A \$50.00 non-refundable deposit is due at the time of booking, this deposit goes towards reserving the party room, and includes invitations and 1 (one) staff member to assist with the party.
- There is a minimum of 5 and maximum of 12 children required for a party reservation.
- You are scheduled for **1 HOUR AND 30 MINUTES** for the total party. You may arrive 30 minutes early to help greet guests and setup.
- **PARTY AREAS** are not decorated, but if you choose, you may bring your own balloons and table decorations. Please do not tape anything on the walls and **no confetti, glitter, silly string or piñatas!!**
- You are welcome to bring the cake, ice cream and drinks. **DON'T FORGET TO BRING A KNIFE, CANDLES, PLATES, UTENSILS, CUPS AND MATCHES!**
- Party options are: Kid Concoctions at 10% off, craft kits chosen from our store at 10% off, or games chosen from our store at 10% off. **ONLY** crafts or games purchased from our store may be used during the party.
- We hold the items especially for your party. **PAYMENT IN FULL** is required at the time the activity is selected and must be paid by cash or credit card.
- If more children are attending than what is stated on the party contract, we cannot guarantee enough party activity kits for the additional children. **Please be specific on the number of guests!**

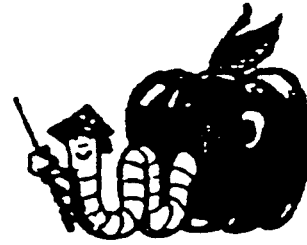

Birthday Party Contract

I understand that birthday presents are allowed but The Parent Teacher Store and Toys Too! is not responsible for lost or stolen presents.

I understand that there is a \$50.00 NON-REFUNDABLE deposit required to book a party.

I understand that once the activity has been selected the total party amount is required to be paid by cash or credit card before the kits/games can be held. Kits/games must be selected from The Parent Teacher Store and Toys Too!.

I understand that The Parent Teacher Store and Toys Too! shall not be liable to the host for any loss or damage to the host or to any other person or to the property of the lessee or of any other person unless such loss or damage shall be caused by or result from a negligent act of omission or commission on the part of The Parent Teacher Store and Toys Too!, or any of its agents, or employees.
